1. Call to Order:

The meeting was called to order by Victor Riches, President of the Board of the Arizona Industrial Development Authority (AZIDA) at 3:30 p.m. Present at the meeting were Victor Riches and Doug Yonko, with Jim Keeley, Mike Godbehere and Lea Marquez Peterson participating via telephone. A quorum was declared present. *Note:* Jim Keeley left the meeting at 3:43 p.m.

2. Adoption of Minutes of the September 25, 2019 AZIDA Board Meeting

Board member <u>Doug Yonko</u> moved to adopt the minutes of the September 25, 2019 AZIDA Board Meeting. Board member <u>Lea Marquez-Peterson</u> seconded the motion.

The Board Members were individually polled - Doug Yonko (yes), Jim Keeley (yes), Lea Marquez-Peterson (yes), Mike Godbehere (yes), Victor Riches (yes), and by a vote of 5-0 the motion passed.

3. Agenda Items Considered:

Presentation, Discussion & Adoption

Approval of Resolution No. 2019-40 — Granting Final Approval Not-to-exceed \$47,000,000 of Education Revenue Bonds (Academies of Math and Science Projects).

Steven Hykes, Academy of Mathematics and Science, Inc. gave a summary of the proposed project and offered to entertain questions from the Board. President Riches commented on what a good job Academy of Mathematics and Science schools are doing and how great that is for the State of Arizona.

Board member <u>Jim Keeley</u> motioned to approve Resolution No. 2019-40 as presented. Board member <u>Mike Godbehere</u> seconded the motion.

Approval of Resolution No. 2019-41 — Granting Final Approval Not-to-exceed \$40,000,000 of Revenue Bonds (Ignatius Hall Development Project).

Tom Beckett of NW Capital Market Inc. gave a summary of the proposed project and offered to entertain questions from the Board.

Board member **<u>Doug Yonko</u>** motioned to approve Resolution No. 2019-41 as presented. Board member **<u>Lea Marquez-Peterson</u>** seconded the motion.

The Board Members were individually polled - Doug Yonko (yes), Jim Keeley (yes), Lea Marquez-Peterson (yes), Mike Godbehere (yes), Victor Riches (yes), and by a vote of 4-0 the motion passed.

Presentation, Discussion & Adoption

Approval of Resolution No. 2019-42 — Amending the Final Approval Resolution No. 2019-37, adopted on September 25, 2019, to revise the project description previously approved to be financed with not-to-exceed \$28,000,000 Education Facility Revenue Bonds (Arizona Christian University Project).

Kelly McGuire explained that the amendment was necessary to revise the description of the project to be financed and offered to entertain questions from the Board.

Board member <u>Mike Godbehere</u> motioned to approve Resolution No. 2019-42 as presented. Board member <u>Doug Yonko</u> seconded the motion.

The Board Members were individually polled - Doug Yonko (yes), Lea Marquez-Peterson (yes), Mike Godbehere (yes), Victor Riches (yes), and by a vote of 4-0 the motion passed.

Presentation, Discussion & Adoption

Approval of Resolution No. 2019-43 —Granting an extension of Preliminary Approval of not-to-exceed \$190,000,000 of Senior Lien Revenue Bonds (Benchmark—Raeford Ethanol Project).

Kelly McGuire explained that the initial preliminary approval was for 180 days and that the extension of the preliminary approval will be for an additional 365 days. She then offered to entertain questions from the Board. President Riches asked whether it was normal for a financing to need a one-year extension in order to complete it. Ms. McGuire said that in a project of this type and complexity, it is typical to request and need an extension of time.

Board member <u>Lea Marquez-Peterson</u> motioned to approve Resolution No. 2019-43 as presented Board member <u>Doug Yonko</u> seconded the motion.

Approval of Resolution No. 2019-44 – Preliminary Approval of a Resolution authorizing not-to-exceed \$25,000,000 of Multifamily Housing Revenue Bonds (Chandler Village Apartment Project).

Chuck Lotzar of Lotzar Law Firm, P.C., gave a summary of the proposed project and offered to entertain questions from the Board.

Board member **<u>Doug Yonko</u>** motioned to approve Resolution No. 2019-44 as presented Board member **<u>Mike Godbehere</u>** seconded the motion.
