Executive Session – If authorized by a majority vote of the Authority members attending the meeting, an executive session will be held immediately following the vote in accordance with A.R.S. § 38-431.03(A)(1) and(3) and the meeting will be temporarily recessed while the board of directors retires to executive session, which will not be open to the public.
